Posts in the Public Service and Provincial Public Service belonging to Field Officer Category

All the officers serving in the posts mentioned in Annex 01 or 02 of Public Administration Circular 33/2017 dated 07.12.2017 are entitled to the allowance for the field officers as per the provisions in the Public Administration Circular 06/2014 dated 31.03.2014, Public Administration Circular 06/2014(I) dated 30.06.2014 and the Public Administration Circular 06/2014(II) dated 03.06.2015.

02. This circular letter is issued considering the representations made stating that the allowances for certain filed officers are not paid in line with the provisions of the Circulars. Hence it is further informed that if there is any issue with regard to the payment of allowance to any officer, relevant head of the institution should forward the issue to the Director General of Establishments and obtain clarifications.
